The Committee on Laws, Rules & Internal Government recommended approval, with amendments/remarks:

- to adopt the Amended Version, attached on pages 165-167; and

- to include all Councilors present during the Committee Hearing as Co-Introducers.

The Committee on Civil Service, Appointments & Reorganization recommended approval, with amendments:

- in Section 1.3 - substitute the word "COORDINATION" to "PLANNING";

- in Section 1.5 - replace the whole paragraph to "THE FOLLOWING INCUMBENT POSITIONS UNDER THE CULTURAL AFFAIRS DIVISION OF THE OFFICE OF THE MAYOR SHALL BE TRANSFERRED TO THE QUEZON CITY TOURISM SERVICES DIVISION";

- in Section 1.5 - delete the positions of Senior Tourism Officer SG-18 and Administrative Aide VI (Electronic and Communications Equipment Technician I) SG-6;

- in Section 1.7 - delete the phrase "...AND PLACED UNDER THE CULTURAL AFFAIRS DIVISION TO CONSOLIDATE RELATED FUNCTIONS" - the paragraph will be read as "THE QUEZON CITY SYMPHONIC BAND COMPOSED OF THE FOLLOWING POSITIONS SHALL BE TRANSFERRED TO THE QUEZON CITY TOURISM DEPARTMENT.";

- in Section 2 - delete the phrase "AND CONVERSION" and insert the word "VACANT" after the word "OF" - this will be read as "ABOLITION OF VACANT POSITIONS.";

- in Section 2.1 - to include the position of City Government Assistant Head (SG-26); and

- Section 2.2 will be deleted.
