ORDINANCE

AUTHORIZING THE GRANT OF FINANCIAL ASSISTANCE TO BARANGAY OFFICIALS, REGULAR MEMBERS OF BARANGAY TANOD BRIGADES IN THE FORM OF YEAR-END CASH INCENTIVES AND APPROPRIATING THE SUM OF THREE MILLION FOUR HUNDRED NINETY THOUSAND TWO HUNDRED PESOS (P3,490,200.00) FOR THE PURPOSE.

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. AUTHORIZATION. The grant of financial assistance to Barangay Officials and Regular Members of the Barangay Tanod Brigades (BSDO) in the form of year-end Cash incentives at rates hereinbelow prescribed, is hereby authorized:

Barangay Official/Barangay Tanod Rates

Punong Barangay - - - - -	P2,500.00
Barangay Kagawad - - - - -	2,000.00
KB Chairman - - - - -	2,000.00
Barangay Secretary - - - - -	1,500.00
Barangay Treasurer - - - - -	1,500.00
Barangay Tanod (Regular) - - - - -	600.00

SECTION 2. APPROPRIATION. The sum of Three Million Four Hundred Ninety Thousand Two Hundred Pesos (P3,490,200.00) is hereby appropriated from the General Fund to carry out the letter and spirit of this City Ordinance.
