WHEREAS, on February 9, 2017, the Quezon City Governement (QCG), represented by Hon. Herbert M. Bautista and Provincial Government of Ilocos Norte (INPG), represented by Hon. Imee R. Marcos signed a Memorandum of Agreement (MOA) for a Producer 2 Consumer Program (P2C) to provide economic opportunities for local farmers and Micro, Small and Medium Enterprise (MSME) owners/producers of Ilocos Norte to showcase and directly market their products in Quezon City;

WHEREAS, the implementation of the program has been successful;
