**AN ORDINANCE APPROVING SUPPLEMENTAL APPROPRIATION NUMBER 1, GENERAL FUND FOR FISCAL YEAR 2019 IN THE AMOUNT OF TWO BILLION FOUR HUNDRED SEVENTY ONE MILLION FOUR HUNDRED EIGHTY ONE THOUSAND SEVEN HUNDRED SEVENTY SEVEN PESOS ONLY (2,471,481,777.00) TO DEFRAY PRIOR YEAR OBLIGATIONS FOR ELECTRICITY EXPENSES UNDER THE MAINTENANCE AND OTHER OPERATING EXPENSES ACCOUNT**

**WHEREAS**, On 18 December 2018, Ordinance No SP 2772, series of 2018 was approved providing for the amount of Twenty One Billion Five Hundred Million Pesos (21,500,000.00) to cover for various expenditures to support the operations, programs, projects and activities of the city government;

**WHEREAS**, Upon the recommendation of the Finance Committee, duly certified by the Local Treasurer, funds are actually available, there is a need to appropriate under this Supplemental Appropriation 1 the amount of Two Billion Four Hundred Seventy One Million Four Hundred Eighty One Thousand Seven Hundred Seventy Seven Pesos Only (2,471,481,777.00) to fund the Maintenance and Other Operating Expense Account;

**NOW, THEREFORE,  
BE IT ORDAINED BY THE QUEZON CITY COUNCIL, IN SESSION  
ASSEMBLED:**

**SECTION 1. APPROPRIATION.** The amount of Two Billion Four Hundred Seventy One Million Four Hundred Eighty One Thousand Seven Hundred Seventy Seven Pesos Only (2,471,481,777.00) is hereby declared as Supplemental Appropriation Number 1, General Fund for Fiscal Year 2019 to be defrayed for the following purposes:

**SECTION 2. AUTHORITY.** The City Mayor is hereby authorized to disburse the funds appropriated under Section 1, hereof consistent with the Project Procurement Management Plan for the purpose consistent with the provisions of RA9184 and its Implementing Rules and Regulations.






**SECTION 5. EFFECTIVITY.** This Ordinance shall take effect immediately upon its approval.


