**A RESOLUTION AUTHORIZING THE QUEZON CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, QUEZON CITY, TO EXTEND FINANCIAL ASSISTANCE AMOUNTING OF FIVE THOUSAND PESOS (P5,000.00) TO EACH OF THE FOUR HUNDRED NINETEEN (419) INFORMAL SETTLER FAMILIES (ISFs) RESIDING IN SITIO SAN ISIDRO, BARANGAYS PROJECT 6 AND BAGONG PAG-ASA, QUEZON CITY, WHO ARE TO BE RELOCATED TO THE NATIONAL HOUSING AUTHORITY (NHA) RESETTLEMENT SITE IN ST. MARTHA, MORONG, RIZAL, WITH A TOTAL AMOUNT OF TWO MILLION NINETY FIVE THOUSAND PESOS (P2,095,000.00).**

**WHEREAS**, based on the 2018 Tagging and Census Validation conducted by the National Housing Authority (NHA), a total of four hundred nineteen (419) informal settler families were verified living in Sitio San Isidro (along Tanque Creek at the back of Philippine Children's Medical Center and inside DENR Compound), Barangays Project 6 and Bagong Pag-Asa, Quezon City;

**WHEREAS**, the subject area is classified as non-residential and considered high risk due to its blighted condition and absence of accessible roads;

**WHEREAS**, portion of the subject area will be affected by the expansion project of the Philippine Children's Medical Center, specifically the construction of new hospital buildings;

**WHEREAS**, in an effort to relocate the aforementioned ISFs to safer grounds, NHA has committed relocation allocation in its resettlement site in St. Martha, Morong, Rizal;

**WHEREAS**, to draw cooperation from the affected ISFs and also to provide them with something to start with at the resettlement site, there is a need for LGU-QC to provide financial assistance to the four hundred nineteen (419) ISFs in the total amount of two million ninety five thousand pesos (P2,095,000.00) or an equivalent amount of five thousand pesos (P5,000.00) per ISF;


**WHEREAS**, in all its business transactions, it is incumbent upon the City Mayor to represent the City and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance as may be found in Section 455(b)(1)(vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;


**NOW, THEREFORE,**

**BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED**, to authorize, as it does hereby authorize, the City Mayor, Honorable Herbert M. Bautista, to extend financial assistance of Five Thousand Pesos (P5,000.00) to each of the four hundred nineteen (419) ISFs residing in Sitio San Isidro, Barangays Project 6 and Bagong Pag-Asa, Quezon City, who are to be relocated to the NHA resettlement site in St. Martha, Morong, Rizal, with a total amount of two million ninety five thousand pesos (P2,095,000.00).
