**A RESOLUTION AUTHORIZING THE QUEZON CITY GOVERNMENT THROUGH MAYOR HERBERT M. BAUTISTA, TO GRANT FINANCIAL ASSISTANCE IN THE AMOUNT OF ONE MILLION PESOS (PHP 1,000,000.00) TO THE QUEZON CITY FORMER BARANGAY KAGAWAD FOUNDATION (QCFBKF), INC., SUBJECT TO EXISTING ACCOUNTING AND AUDITING LAWS, RULES AND REGULATIONS.**

WHEREAS, the Quezon City Former Barangay Kagawads Foundation (QCFBKF) Inc., duly registered with the Securities and Exchange Commission with Registration No. CN201201681, is a non-stock and non-profit organization;

WHEREAS, the QCFBKF, Inc. was accredited at the Community Relations Office (now Barangay and Community Relations Department) through Quezon City Ordinance No. SP-2311, Series of 2014 dated 20 October 2014;

WHEREAS, QCFBKF's main objective is to extend assistance to the community especially to its members who are former Barangay Kagawads of the Quezon City Government;

WHEREAS, Mayor Herbert M. Bautista acceded to assist the Quezon City Former Barangay Kagawads Foundation, Inc. in every reasonable means by granting the request of financial assistance amounting to One Million Pesos (Php 1,000,000.00) to carry out its mandate, projects and activities;

WHEREAS, pursuant to Section 36 of Republic Act 7160, otherwise known as the "Local Government Code of 1991" expressly provides:

*Secion 36. Assistance to People's and Non-Governmental Organizations. - A local government unit may, through its local chief executive and with the concurrence of the sanggunian concerned,*


provide assistance, financial or otherwise, to such people's and non-governmental organizations for economic, socially-oriented, environmental, or cultural projects to be implemented within its territorial jurisdiction.

**NOW, THEREFORE,**

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize, to the Quezon City Government through Mayor Herbert M. Bautista, to grant financial assistance in the amount of One Million Pesos (Php 1,000,000.00) to Quezon City Former Barangay Kagawads Foundation (QCFBKF), Inc., subject to existing accounting and auditing laws, rules and regulations.
