A RESOLUTION AUTHORIZING THE CITY MAYOR HONORABLE HERBERT M. BAUTISTA, QUEZON CITY, TO PURCHASE ONE (1) UNIT OF L-300 VAN MOTOR VEHICLE, TO BE DONATED TO BGY. GRACEVILLE, SAN JOSE DEL MONTE, BULACAN, INTENDED TO BE USED AS MULTI-FUNCTIONSERVICE VEHICLE FOR THE ISFS-RELOCATEES FROM QUEZON CITY RESETTLED TO NHA RESETTLEMENT SITE IN BGY. GRACEVILLE, SAN JOSE DEL MONTE, BULACAN.

WHEREAS, about 500 informal settler families (ISFs) belonging to the group of Mr. Edwin Nakpil from North Triangle, Bgy. BagongPag-Asa, Quezon City, were relocated to NHA Resettlement Sites situated within the territorial jurisdiction of Bgy. Graceville, San Jose Del Monte, Bulacan;

WHEREAS, due to sudden increase in population and the lack of support services from the Relocation Program of the national government, the Barangay Council of Bgy. Graceville has been expressing concern on how it could cope up and provide the necessary services and assistance requirement of the ISFs-relocatees;

WHEREAS, given the above-cited circumstances, the Task Force on socialized housing and development of blighted areas (TF Housing) has recommended the purchase and donation of one (1) unit of L-300 Van to Barangay Council of Bgy. Graceville, San Jose Del Monte, Bulacan;



NOW, THEREFORE,




