A RESOLUTION AUTHORIZING THE CITY MAYOR HONORABLE HERBERT M/. BAUTISTA, QUEZON CITY, PURCHASE TWO (2) UNITS OF L-300 VAN MOTOR VEHICLES, TO BE DONATED TO BARANGAY MAYBANGCAL, MORONG, RIZAL, INTENDED TO BE USED AS MULTI-FUNCTION SERVICE VEHICLES FOR THE ISFS-RELOCATEES FROM QUEZON CITY RESETTLED TO NHA RESETTLEMENT SITE (ST. MARTHA) IN BGY. MAYBANGCAL, MORONG RIIZAL.

WHEREAS, a Memorandum of Agreement (MOA) dated February 9, 2017 was entered into by and among the Quezon City Government (LGU-QC), Municipal Government of Morong, Rizal (LGU-MORONG) and National Housing Authority (NHA), exclusively allocating all the 3,100 housing units at NHA Resettlement Site (St. Martha), Bgy. Maybangcal, Morong Rizal;

WHEREAS, considering that all the 3,100 housing units in St. Martha are situated within the territorial boundary of Bgy. Maybangcal, the Barangay Council has expressed concerns on how it could cope up with needs for services and assistance brought about by sudden increase in population and lack of support services from the relocation program of the national government;

WHEREAS, given the above-cited circumstances, the Task Force on Socialized Housing and Development of Blighted Areas (TF Housing ) has recommended the purchase and donation of 2 units of L-300 Van to Barangay Council of Bgy. Maybangcal, Morong, Rizal;


WHEREAS, pursuant to Section 455 (b) (1) of Republic Act 7160, otjerwise known as the "Local Government Code of 1991", the City Mayor shall represent the City in all its transactions and sign in its behalf all bonds, contract and obligations, and such other documents upon the authority of the Sangguniang Panlungsod or pursuant to law or ordinance.

NOW, THEREFORE,


