PROPOSED RESOLUTION NO. _____, S-2019

A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE MAYOR HERBERT M. BAUTISTA, TO GRANT FINANCIAL ASSISTANCE IN THE AMOUNT OF ONE MILLION PESOS (PHP 1,000,000.00) TO NOVALICHES HIGH SCHOOL ALUMNI ASSOCIATION, INC. (NHSAAI), SUBJECT TO EXISTING LAWS, RULES AND REGULATIONS.

WHEREAS, the Novaliches High School Alumni Association Inc. (NHSAAI) is an organization duly registered under the laws of the Philippines composed of all batches from 1964 up to 2018 and with address at Lakandula St., TS Cruz Subdivision, Barangay San Agustin, Novaliches, Quezon City;

WHEREAS, the NHSAAI has identified and prioritized the following programs and projects that would benefit and bring positive changes to its members and to the association as a whole, to wit:

1. Launching of Alumni Summer Olympics tentatively scheduled this coming March 31, 2019 which aims to gather all batch alumni once again in their beloved alma mater to compete in different friendly games and imbibe the value of sportsmanship; to underline the importance of improving and maintaining physical fitness; and to bring the alumni closer as they develop deeper friendship and unity. This will be participated by at least 35 basketball teams, 15 volleyball teams representing various batches including chess tournament, swimming, table tennis, marathon, cycling, body building and other sports;
2. Customized uniforms with name, position and batch year for NHSAAI Officers, Alumni Batch Leaders, Olympics participants, Players and Volunteer students;
3. Data base of all alumni for their professions, skills and talents, present employment in private companies and government affiliations as well as to put up official website for the alumni where they can communicate and extend services;

4. To organize and strengthening various batch alumni associations as partners of the Quezon City Government; and
5. Team Building and Strategic Planning Seminar for 120 participants;

WHEREAS, on February 20, 2019, the Officers of the said association sent a request letter to the Sanggunican Panglungsod for financial assistance amounting to One Million Pesos (Php 1,000,000.00) to help defray the expenses of the abovementioned programs and projects;

WHEREAS, pursuant to Section 36 of Republic Act 7160, otherwise known as the "Local Government Code of 1991" expressly provides:


Section 36. Assistance to People's and Non-Governmental Organizations. - A local government unit may, through its local chief executive and with the concurrence of the sanggunian concerned, provide assistance, financial or otherwise, to such people's and non-governmental organizations for economic, socially-oriented, environmental, or cultural projects to be implemented within its territorial jurisdiction.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize, to the City Mayor, Honorable Herbert M. Bautista, to grant financial assistance in the amount of One Million Pesos (Php 1,000,000.00) to Novaliches High School Alumni Association, Inc. (NHSAAI), subject to existing laws, rules and regulations.
