ORDINANCE

APPROPRIATING FUNDS FOR SUPPLEMENTAL BUDGET NO. 3, GENERAL FUND AND SUPPLEMENTAL BUDGET NO. 2, INFRA-STRUCTURE FUND, IN THE TOTAL SUM OF FORTY FIVE MILLION ONE HUNDRED EIGHTY FOUR THOUSAND NINETY FIVE PESOS (P45,184,095.00), FOR THE OPERATION OF THE CITY GOVERNMENT.

Be it ordained by the City Council of Quezon City in session assembled:

SECTION 1. Supplemental Budget No. 3, General Fund, in the amount of P43,904,095.00 and Supplemental Budget No. 2, Infrastructure Fund in the amount of P1,280,000.00, are hereby approved, summarized as follows:

SECTION 3. This Ordinance shall take effect upon its approval.


