## Ordinance No. NC- 60, S-88

## ORDINANCE

PRESCRIBING AND FIXING THE FEES IN THE FILING, REGISTRATION AND ISSUANCES OF DOCUMENTS AT THE LOCAL CIVIL REGISTRAR OF QUEZON CITY.

Introduced by Councilor Jorge L. Banal and Co-Introduced by Councilor Alberto M. Galarpe.

Be it ordained by the City Council of Quezon City in session assembled:

Section 1. Imposition of Fees - The following fees shall be collected for the corresponding services rendered by the Civil Registrar of Quezon City:

heirs or assignees shall be entitled to the perpetual use of said lot, plot, grave or niche. subject to cemetery regulations.

- Rental Fee for the use of the Chapel:
  - 1. For less than an hour -Free
  - 2. For every hour or fraction thereof- P 5.00
  - 3. For deposit of a body in its urn to cask, per day - - -20.00
  - 4. For the care of a lot or plot, per 30.00

Time of Payment - The fees shall be paid to Section 2. the City Treasurer, upon order of payment issued by Local Civil Registrar and before the release of the document. In case of failure to pay, the rental fee for niches, graves or plots, the remains shall be exhumed and the grave, niches, or plots shall be declared vacant. The remain exhumed shall be deposited in graves, niches or jars as may be expedient and with proper identification.

Section 3. Exemption. The herein prescribed fees shall not be collected on the following cases:

- Certification/certified copies of documents for official use at the request of a court or government
- Issuance of birth certificate of children reaching school age whom such certificate are required for admission to the primary grade of the public school.

Section 4. Section 5.31 to Sec. 5.33 of Article VIII of Ordinance 10700 are hereby repealed. All other ordinances or parts thereof which are in conflict with this ordinance are hereby repealed or modified accordingly.

Section 5. This Ordinance shall take effect upon its approval.
