ORDINANCE

APPROVING SUPPLEMENTAL BUDGET NO. 1, S-89, APPROPRIATING FIFTY-SIX MILLION SEVEN HUNDRED FIFTY-THREE THOUSAND TWO HUNDRED ONE PESOS (P56,753,201.00) UNDER THE GENERAL FUND AND FORTY-TWO MILLION SIXTY THOUSAND PESOS (P42,060,000.00) UNDER INFRASTRUCTURE FUND, OR A TOTAL SUM OF NINETY-EIGHT MILLION EIGHT HUNDRED THIRTEEN THOUSAND TWO HUNDRED ONE PESOS (P98,813,201.00), TO COVER VARIOUS EXPENSES OF THE CITY GOVERNMENT.

Be it ordained by the City Council of Quezon City in session assembled:


SECTION 1. Supplemental Budget No. 1 for the Calendar Year 1989 involving the amount of Fifty-Six Million Seven Hundred Fifty-Three Thousand Two Hundred One Pesos (P56,753,201.00) under the General Fund and Forty-Two Million Sixty Thousand Pesos (P42,060,000.00) under the Infrastructure Fund is hereby approved, the documents containing the various items of expenditures are attached herewith and are hereby made an integral part of this ordinance.


SECTION 2. There are hereby appropriated from the General Fund the amount of Fifty-Six Million Seven Hundred Fifty-Three Thousand Two Hundred One Pesos (P56,753,201.00) and from the Infrastructure Fund the amount of Forty-Two Million Sixty Thousand Pesos (P42,060,000.00), or a total of Ninety-Eight Million Eight Hundred Thirteen Thousand Two Hundred One Pesos (P98,813,201.00) to cover various expenses provided for under Section 1, hereof.

SECTION 3. This ordinance shall take effect upon its approval; Provided, that any item of appropriation in this Supplemental Budget No. 1 which may require exemption or authority from the Commission on Elections, shall be operative only upon


compliance of said requirement if found necessary
under the law.
