Be it ordained by the City Council of Quezon City in session assembled:

SECTION 1. The Quezon City Annual Development Plan for Calendar Year 1989 adopted by the City Development Council under its Executive Committee Resolution No. 01, S-89 for the development of the Quezon Memorial Circle/Park is hereby approved. A copy of the aforecited development plan is attached with this Ordinance and is hereby made an integral part hereof.

SECTION: 2. There is hereby appropriated the sum of Twenty-Two Million Five Hundred Twenty Thousand One Hundred Fifty-Nine Pesos (P22,520,159:00), or so much thereof as may be necessary, to be made available for the implementation of the development plan approved under Section One hereof, the amount to be taken from the 20% share of the City from annual Internal Revenue Allotment.

SECTION 3. This Ordinance shall take effect upon its approval.
