ORDINANCE
ESTABLISHING THE QUEZON CITY STREET SCHOOL FOR
STREET CHILDREN UNDER THE SOCIAL WELFARE SERVICES
DEPARTMENT AND APPROPRIATING THE AMOUNT OF THREE
HUNDRED THOUSAND PESOS (\$\frac{1}{2}\$300,000.00) AS ADDITIONAL
APPROPRIATION FOR THE PURPOSE.

WHEREAS, every child is endowed with reason, dignity and worth regardless of social and economic background and efforts should be directed towards his physical and mental nourishment, survival and total development;

WHEREAS, the increasingly growing urban population, coupled with the inequitable distribution of resources and wealth and inadequate social services, have led to the proliferation of street children;

WHEREAS, street children are exposed daily to harmful influences that disensitize and distort their values, characters and personalities;

WHEREAS, street children are beyond the reach of educational institutions as most of them have dropped out from school in order to earn to survive or to supplement family income through street hawking, vending and other odd jobs, both legal and illegal;

WHEREAS, to ensure that street children are given the opportunity for a bright future and to lead wholesome and productive lives, there is a need for the City to undertake an educational program that could reach out into their milieu, the streets;

NOW, THEREFORE.

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. There is hereby established a Quezon City Street School for street children under the Social Welfare Services Department, to administer and implement a Street School Program for Street Children, which is hereto attached.

SECTION 2. There is hereby appropriated the amount of THREE HUNDRED THOUSAND PESOS (\$300,000.00), in addition to the One Hundred Thousand Pesos (\$100,000.00) appropriated from the Annual Budget for the establishment of the Street School.

SECTION 3. Additional funding and other forms of support shall be sourced from the private sector.

SECTION 4. This Ordinance shall take effect upon its approval.
