ORDINANCE

CREATING TWO PLANTILLA POSITIONS OF LEGAL OFFICER IV, ONE PLANTILLA POSITION OF STENOGRAPHIC REPORTER II, ONE PLANTILLA POSITION OF CLERK II AND ONE PLANTILLA POSITION OF UTILITY WORKER II UNDER THE BARANGAY OPERATIONS CENTER WHICH WILL PROVIDE LEGAL ASSISTANCE TO BARANGAY OFFICIALS PURSUANT TO SECTION 458 (a) (1) OF THE LOCAL GOVERNMENT CODE OF 1991, AND APPROPRIATING THE NECESSARY FUNDS FOR THE PURPOSE.

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. Creation - There is hereby created two (2) plantilla positions of Legal Officer IV, one (1) plantilla position of Stenographic Reporter II, with salary grades 22 and 8, respectively, one (1) plantilla position of Clerk II with salary grade 4 and one (1) plantilla position of Utility Worker II with salary grade 3, under the Barangay Operations Center.

SECTION 2. Purpose - The positions created under the preceding section shall provide legal assistance to barangay officials, who in the performance of their official duties or occasion thereof, have to initiate and prosecute judicial proceedings or defend themselves against legal actions.

SECTION 3. Appropriation - The amount of Eighty Nine Thousand Two Hundred Ninety Six Pesos, (P89,296.00), is hereby appropriated from the City Treasury to cover the payment of salaries, insurances and other benefits for the positions created under Section 1 hereof from October 1, 1992 to December 31, 1992, the breakdown of which is as follows:



SECTION 5. Effectivity - This Ordinance shall take effect immediately upon its approval.


