ORDINANCE

GRANTING FINANCIAL ASSISTANCE TO KAGAWAD NEMECIO T. LACANILAO, A BARANGAY KAGAWAD OF BARANGAY KAMUNING, QUEZON CITY, WHO SUSTAINED AND SUFFERED TOTAL PHYSICAL DISABILITY WHILE IN LINE OF DUTY ON FEBRUARY 4, 1992 IN THE AMOUNT OF FIFTY THOUSAND PESOS (P50,000.00) TO BE CHARGED AGAINST THE APPROPRIATION FOR GRANTS, SUBSIDIES AND CONTRIBUTIONS UNDER THE 1992 SUPPLEMENTAL BUDGET OF THE OFFICE OF THE CITY MAYOR OR FROM SUCH OTHER OFFICES WHERE FUNDS ARE AVAILABLE.

WHEREAS, Kagawad Nemecio T. Lacanilao while in the performance of his duties on the night of February 4, 1992, was intentionally ran-over by an A.U.V. - light truck (Fiera) by suspected criminals whose case are now pending before the Trial Court;

WHEREAS, as the result of the foregoing, Kagawad Nemecio T. Lacanilao sustained both moral and physical damages and injuries which resulted in the amputation of both his lower extremities or legs at the Veterans Memorial Medical Center where he was operated and confined, and now a physical disable;

WHEREAS, Kagawad Nemecio T. Lacanilao incurred enormous financial accountabilities due to his continuous medical treatment and was deprived of his usual gainful employment leaving him virtual destitution;

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY
IN SESSION ASSEMBLED:

SECTION 1. A financial assistance in the amount of Fifty Thousand Pesos (P50,000.00) is hereby granted to Kagawad Nemecio T. Lacanilao, a Barangay Kagawad of Barangay Kamuning, Quezon City.

SECTION 2. There is hereby appropriated the amount of Fifty Thousand Pesos (P50,000.00) by way of grant to be taken/charged against the appropriation for grants, subsidies, and contributions under the 1992 Supplemental Budget of the Office of the City Mayor or from any available funds from such other offices where funds are available.

SECTION 3. This Ordinance shall take effect immediately upon its approval.
