ORDINANCE NO. SP- 139, S-93

AN ORDINANCE APPROPRIATING THE SUM OF ONE MILLION SIX HUNDRED EIGHTY-SEVEN THOUSAND FIVE HUNDRED PESOS (₱1,687,500.00) FOR THE PURCHASE AND MAINTENANCE OF ONE (1) UNIT OF BOOKMOBILE.

WHEREAS, the Quezon City Public Library has, for the last two (2) years, been operating a bookmobile, touring the City's four (4) Districts, concentrating most of the time in the depressed areas;

WHEREAS, as a "library on wheels", its personnel provide not only reading materials but also conduct story telling sessions and on the spot drawing contests for children, while handouts of literature on livelihood and do-it-yourself projects are given to jobless adults and housewives;

WHEREAS, this outreach service strategy of the Quezon City Public Library has become one of the City Government's most effective agencies in delivering social and educational services, so much so that it was recently featured in the tri-media: Bulletin Today, B-16 (Sept. 2), TV Channel 5 (Sept. 4), Sky Cable Channel 29 (Sept. 9), and Radio Station DSMM (Sept. 13);

WHEREAS, this service which, so far is the only one of its kind in the country is soon to be discontinued because the utility value of the bookmobile which was a converted bus of 1972 model donated by the Taiwan Government to the Quezon City Government in 1990, has just about come to an end;

WHEREAS, to sustain this singular but effective means of servicing Quezon City residents it is but proper that a new and better equipped unit is purchased;

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, that:

SECTION 1. The amount of One Million Six Hundred Eighty-Seven Thousand Five Hundred Pesos (P1,687,500.00) is appropriated for the purchase and maintenance of one (1) unit of bookmobile, to wit:

A. Capital Outlay (one unit of bookmobile including furniture & equipment) - - - P1,500,000

B. Books Outlay

- 1. Books for children & adults - P100,000
- 2. Audio/Visuals - - - - - 25,000
- 3. Recreational Materials - - - 15,000
- 4. Livelihood Literature - - - - 5,000

C. Maintenance/Operating Expenses

- 1. Gasoline & Oil - - - - - P 20,000
- 2. Repair/servicing/spare parts- 10,000
- 3. Subscription & Supplies - -- 10,000
- 4. Printing and binding - - - - 2,500

SECTION 3. This Ordinance shall take effect upon approval of the 1994 budget of the City Government.


