AN ORDINANCE GRANTING INDIVIDUAL FRANCHISES TO THE
HEREIN NAMED PETITIONERS FOR THE OPERATION OF
MOTORIZED TRICYCLE-FOR-HIRE WITHIN SPECIFIED
ZONE/ROUTE IN QUEZON CITY AS RECOMMENDED BY THE
TRICYCLE FRANCHISING BOARD OF THE CITY COUNCIL
IN ITS BOARD RESOLUTION NO. 03, SERIES OF 1993,

AS AN INTEGRAL PART HEREOF.

WHEREAS, Ordinance No. SP-15, S-92, enacted
pursuant to the provision of Sec. 458, 3(vi) of
the Local Government Code of 1991, mandates the
City Council to regulate the operation of tricycles
and grant franchises for the operation thereof with-
in the territorial jurisdiction of Quezon City;

WHEREAS, in view of the foregoing legislative
authority, the City Council, thru its Tricycle
Franchising Board, has received numerous petitions
for individual franchises to operate motorized
tricycle-for-hire within specified zones/routes in
Quezon City;

WHEREAS, after due hearings, the Tricycle
Franchising Board found that a good number of said
petitions are in conformity with the criteria and
requirements set forth under Ordinance No. SP-15,
S-92 and in other issuance relative thereto, and
thereby recommended that said petitioners be
granted Motorized Tricycle Operators Permit as
reflected in its Board Resolution No. 03, Series
of 1993, a copy of which is also attached herewith
and made as an integral part hereof;



SECTION 2. This Ordinance shall take effect immediately upon its approval.


