AN ORDINANCE APPROPRIATING THE SUM OF ONE HUNDRED EIGHT THOUSAND EIGHT HUNDRED SIXTY PESOS (P108,860.00) FOR PURCHASE OF TWO (2) SETS OF LAW BOOKS AND OTHER PUBLICATIONS BY WAY OF UP-DATING/COMPLETING THE REFERENCE MATERIALS IN THE LAW RESEARCH SECTION OF THE QUEZON CITY PUBLIC LIBRARY.

WHEREAS, the most availed of services of the Quezon City Public library is its Law Research Section where researchers, among whom are lawyers, law students, court personnel, and heads of various private and government offices, flock every working day;

WHEREAS, presumably because of budgetary constraints during the past administrations, the continuing series of publication such as the Philippine Reports, Supreme Court Reports Annotated (SCRA) and Official Gazettes were not kept up-to-date, not to mention individual books (Labor, Corporation, Internal Revenue Codes) and other reference materials (Banking Laws, Lawyers, Review, etc.) which are in constant demand by researchers;

WHEREAS, to remedy the situation, purchase of the books needed to complete the serial publications of the Philippine Reports, Supreme Court Reports Annotated (SCRA) and Official Gazettes, as well as other individual law books is in order;

WHEREAS, the Chief of the Quezon City Library has submitted a list of those much asked for books

totalling 273 volumes (two (2) sets) with an aggregate cost of ₱108,860.00, requesting an appropriation for purchase thereof.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, that:


SECTION 1. The amount of One Hundred Eight Thousand Eight Hundred Sixty Pesos (₱108,860.00) is hereby appropriated for the purpose of purchasing the two (2) sets of law books/publications needed at the Law Research Section of the Quezon City Public Library, per list hereto attached prepared by the Chief Librarian.


SECTION 2. This appropriation shall be included in the annual budget of the Quezon City Government for 1994.

SECTION 3. This Ordinance shall take effect upon approval of the 1994 Budget of the Quezon City Government.


