ORDINANCE NO. SP-\_\_\_\_\_, S-94

AN ORDINANCE AMENDING SECTIONS 1, 2 AND 3 OF ORDINANCE NO. NC-223, S-94 ENTITLED "AN ORDINANCE PROVIDING FOR BURIAL BENEFITS FOR BARANGAY OFFICIALS AND REGULAR MEMBERS OF BARANGAY TANOD BRIGADES AND APPROPRIATING NECESSARY FUNDS THEREFOR", SO AS TO INCLUDE DULY ELECTED SANGGUNIANG KABATAAN OFFICIALS INCLUDING SK SECRETARIES AND TREASURERS, AND PROVIDING THE NECESSARY FUNDS THEREFOR.

WHEREAS, the duly elected officials of the Sangguniang Kabataan of Quezon City, the SK Secretaries and Treasurers upon assumption of office are considered barangay officials;

WHEREAS, these Sangguniang Kabataan Officials in the performance of their duties are exposed to the same risks and hazards whereby in certain instances, may cost their lives;

WHEREAS, at present these Sangguniang Kabataan officials are not covered by any benefit nor entitled to any emolument unlike those given to the regular barangay officials and tanods;

WHEREAS, these Sangguniang Kabataan Officials, considering the risks to their lives and limbs, should be given the necessary benefits to answer unforeseen eventualities;

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY  
IN SESSION ASSEMBLED:

SECTION 1. The provisions of Sec. 1 under Ordinance No. NC-223, S-91 entitled "AN ORDINANCE PROVIDING FOR BURIAL BENEFITS FOR BARANGAY OFFICIALS AND REGULAR MEMBERS OF BARANGAY TANOD BRIGADES AND APPROPRIATING NECESSARY FUNDS THEREFOR", is hereby amended to read as follows:

"Section 1. Establishment of Burial Benefits Fund for Barangay Officials, regular members of Barangay Tanod Brigades and duly elected Sangguniang Kabataan Officials including the SK Secretaries and Treasurers. - There is hereby established in the City Treasury an account to be known as Burial Benefit Fund for Barangay officials, regular member of Barangay Tanod Brigades, duly elected Sangguniang Kabataan officials including SK Secretaries and Trasurers all of Quezon City, who die in line of duty".

SECTION 2. The provisions of Sec. 2 of the same ordinance is hereby amended to read as follows:

"Section 2. Implementation. - The Burial Benefit Fund for Barangay officials, regular members of Barangay Tanod Brigades and duly elected Sangguniang Kabataan officials including SK Secretaries and Treasurers shall be held in trust by the City Treasurer and used for this purpose only. Each of the above-mentioned officials shall be entitled to Thirty Thousand Pesos (P30,000.00) Burial Benefit. Claims against the Fund must be supported by actual burial expenses, and shall be extended only upon presentation of proof of death of the Barangay officials, regular members of the Barangay Tanod Brigades and duly elected Sangguniang Kabataan officials including SK Secretaries and Treasurers to the Barangay Operations Center, or his surviving legal heirs".

SECTION 3. The provisions of Sec. 3 of said ordinance is hereby amended, which shall read as follows:


"Sec. 3. Appropriations. - There is hereby appropriated the sum of TWO MILLION PESOS (P2,000,000.00) from the general fund for the purpose of funding the Burial Benefit Fund of Barangay officials, regular members of Barangay Tanod Brigades and duly elected Sangguniang Kabataan officials including the SK Secretaries and Treasurers as provided in Section 1 hereof".

SECTION 4. Effectivity. - This Ordinance shall take effect upon its approval.


