ORDINANCE NO. SP-292, S-95

AN ORDINANCE FURTHER AMENDING SECTION 5 OF ORDINANCE NO. SP-15, S-92, AS AMENDED, SO AS TO PROVIDE A REGULAR SUPPORT STAFF OF THE TRICYCLE FRANCHISING BOARD, DESIGNATE THE FREQUENCY OF ITS SESSION, AND APPROPRIATE FUNDS FOR THE PURPOSE.

WHEREAS, in pursuance of its devolved power specified under Section 458 (3) (vi) of the Local Government Code of 1991 the City Council created by virtue of Ordinance No. SP-15, S-92, as amended, the Tricycle Franchising Board to serve as its arm in regulating motorized tricycles and granting franchises for their operations;

WHEREAS, being an income-generating agency of the City Council, the Tricycle Franchising Board has been since its inception realizing an estimated income of about P3.3 M per annum;

WHEREAS, ironically, considering the complex function performed by the Board, there is no regular support staff that would carry on its day-to-day activities in regulating the more than sixteen thousand (16,000) motorized tricycles operating in Quezon City;

## NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. Section 5 of Ordinance no. SP-15, S-92, as amended, is hereby further amended so as to include the following Section 5-A and Section 5-B thereof:

SECTION 5-A. <u>Sessions.</u> - The Board shall meet in regular session once a week. A special session may be convened anytime upon request of any of its members but not to exceed four (4) times a month. The presence of any four (4) members shall constitute a quorum to transact official business.

The four (4) TODA representative members shall be entitled to an honorarium of Five Hundred Pesos (P500.00) each per session.

## SECTION 5-B. - Staff Requirement. -

To carry on, man and execute the day-to-day administrative functions of the Board, the following support staff is hereby created:

The Legislative Staff Officer VI shall act as the Head of Staff and Secretary of the Board.

SECTION 2. There is hereby appropriated the amount of Five Hundred Thousand Pesos (P500,000.00) chargeable against the item of appropriation for Tricycle Franchising Board under the Special Project of the City Mayor as reflected in the 1995 Annual Budget.

SECTION 3. All existing ordinances, rules and regulations inconsistent with the provisions of this ordinance are hereby repealed or modified accordingly.
