Ordinance No. SP-314, S-95

AN ORDINANCE AMENDING QUEZON CITY ORDINANCE NO. SP-75, S-93 AND ORDINANCE NO. SP-287, S-95, AND PROVIDING THE NECESSARY FUNDS FOR THE PURPOSE.

WHEREAS, there is a need to amend QC Ordinance No. SP-75, S-93 and Ordinance No. SP-287, S-95 for the following purposes:

1. To conform with Civil Service Laws, Rules and Regulations particularly that of Section 2, par. 2.7 of CSC Memorandum Circular No. 19, s.1992, which provides that:

"No change in designation or nomenclature of positions resulting in a promotion or demotion in rank or increase or decrease in compensation shall be allowed, except when the position is actually vacant, and the filling of such position shall be strictly made in accordance with Civil Service Law, Rules and Regulations.";

2. To conform with Republic Act No. 6758, otherwise known as the "Salary Standardization Law", particularly regarding the corresponding salary grades of plantilla positions provided for under the said law;
3. To place all the positions next to the Section Chief at par with each other.

NOW, THEREFORE,

SECTION 1. Ordinance No. SP-75, S-93 is hereby amended as indicated in the herewith attached documents marked as Annex A-1 to Annex A-13, and made as integral parts of this Ordinance.

SECTION 2. Ordinance No. SP-287, S-95 is hereby amended by upgrading the position of Management and Audit Analyst II created therein to Management and Audit Analyst III.

SECTION 3. The amended plantilla positions of the Office of the City Secretary shall be in accordance with the herewith attached documents marked as Annex B-1 to Annex B-7, and made as integral parts of this Ordinance.

SECTION 4. The sum specifically appropriated under the 1995 Quezon City Annual Budget for the positions amended under this Ordinance is hereby automatically appropriated for the same positions as amended. For any budgetary deficiency, the Vice Mayor and Presiding Officer is hereby authorized to augment the appropriations for Personal Services of the Office of the City Secretary from the savings of that Office under the same expense class. However, if the available savings are not sufficient for the purpose, the deficiency shall be funded in the supplemental or annual budgets of the City Government.


SECTION 5. If, for any reason or reasons, any part or provision of this Ordinance shall be held to be invalid, other parts or provisions hereof which are not affected thereby shall continue to be in full force and effect.

SECTION 6. This Ordinance shall take effect immediately upon its approval.
