AN ORDINANCE CHANGING THE NAME OF THE G.S.I.S. VILLAGE HIGH SCHOOL TO ISMAEL MATHAY, SR. HIGH SCHOOL.

WHEREAS, there are now two (2) schools in Quezon City named after the Government Service Insurance System, namely, the G.S.I.S. Village Elementary School and the GSIS Village High School, both located at the GSIS Village;

WHEREAS, the repetitive use as a nomenclature of the term GSIS by way of identifying landmark edifices in the same general area oftentimes lead to confusion and misdelivery of mail matters;

WHEREAS, on the other hand, there are illustrious sons of Quezon City who, apart from being good fathers to their families, had contributed to the growth and development of Quezon City and, thus, deserve to be publicly honored;

WHEREAS, one such personality is ISMAEL MATHAY, SR., civil servant, community leader, and known far and wide as Auditor General of the Philippines whose tenure of office covered the formative years of the Republic;

WHEREAS, the Barangay Council of Barangay Sangandaan adopted its Resolution No. 39, S-94, requesting the Quezon City Council to change the name of GSIS Village High School into Ismael Mathay, Sr. High School as "it will redound to the greater honor of the aforesaid high school and to the late ISMAEL MATHAY, SR.," the memory of Quezon City's beloved patriarch and one of the Commission on Audit's founding fathers is, thus, perpetuated;

NOW, THEREFORE,


BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. The name of G.S.I.S. Village High School located at the GSIS Village, Quezon City, is hereby changed into Ismael Mathay, Sr. High School.

SECTION 2. This Ordinance shall take effect upon its approval.


