Ordinance No. SP- 403, S-96

AN ORDINANCE FURTHER AMENDING SECTION 5-B (A) OF ORDINANCE NO. SP-292, S-95, AS AMENDED, SO AS TO RESCHEDULE THE SALARY GRADE OF THE POSITION CREATED THEREIN.

WHEREAS, under Section 5-B (A) of Ordinance No. SP-292, S-95, as amended, the position of Legislative Staff Officer VI was intended to be just at the level of an Assistant Division Chief, but the salary attached to the position (Grade 24) had virtually elevated the same to the level of a Division Chief;

WHEREAS, corrections must be effected by lowering the salary range of the said position from Grade 24 to Grade 22 in order to reflect the real intent for which said position was originally conceived;



NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. Section 5-B (A) of Ordinance No. SP-292, S-95, as amended, is further amended to read as follows:


“Section 5-B. Staff Requirement. To carry on, man and execute the day-to-day administrative functions of the Board, the following support staff are hereby created:

	<u>Grade/Step</u>	<u>Rate/P.A.</u>
A. Two (2) Legislative Staff Officer V	22	P119,400.00 ea.

A Legislative Staff Officer V shall act as the Secretary of the Board and the other as the Legal Officer.”

SECTION 2. This Ordinance shall take effect immediately upon approval.
