ORDINANCE NO. SP- 174, S-96

AN ORDINANCE REQUIRING THE WEARING OF UNIFORM AMONG TRICYCLE DRIVERS WHILE OPERATING FOR-HIRE TRICYCLE UNITS WITHIN THE TERRITORIAL LIMITS OF QUEZON CITY AND PROVIDING PENALTIES FOR VIOLATION THEREOF.

WHEREAS, one of the devolved functions of local government units as provided under Section 458 (a) (3) (vi) of the Local Government Code of 1991 is to regulate the operation of tricycles and grant franchises for the operation thereof within the limits of their respective territorial jurisdiction;

WHEREAS, circumscribed within this legislative authority is the power to require tricycle drivers to wear prescribed uniforms not only for proper identification and professionalization of the trade but also for eliciting trust, respect and confidence of passengers, thereby promoting convenience and comfort among the riding public as mandated under the general welfare clause in Section 16 of the same aforesaid code.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:


SECTION 1. All tricycle drivers are hereby required to wear plain t-shirt (with or without collar), that will conform with the district's color scheme (blue for 1st district, yellow for 2nd district, red for 3rd district and green for 4th district) and dark long pants and shoes, while operating for-hire tricycle units within the territorial limits of Quezon City.

SECTION 2. Any violation of this Ordinance shall be punished by a fine of two hundred pesos (P200.00) for the first offense, two hundred fifty pesos (P250.00) for the second offense, and three hundred pesos (P300.00) for the third offense and cancellation of the driver's identification card issued by the Tricycle Regulatory Unit.


SECTION 3. Any ordinance, executive order, rules and regulations, or parts thereof which are inconsistent with this Ordinance are hereby repealed or modified accordingly.

SECTION 4. This Ordinance shall take effect immediately thirty (30) days after its publication in a newspaper of general circulation.
