ORDINANCE NO. SP- 279, S-96

AN ORDINANCE DIVIDING THE 2ND DISTRICT OF QUEZON CITY INTO TWO (2) SEPARATE AREAS AS DISTRICT II-A (TODA) AND DISTRICT II-B (TODA) FOR PURPOSES OF TRICYCLE OPERATORS AND DRIVERS ASSOCIATION (TODA) REPRESENTATION IN THE QUEZON CITY TRICYCLE FRANCHISING BOARD.

Introduced by Councilors BAYANI V. HIPOL, JORGE L. BANAL, WINSTON "Winnie" T. CASTELO, MA. FRESCA M. BIGLANG-AWA, GODOFREDO T. LIBAN II, MARCIANO P. MEDALLA, ANTONIO V. HERNANDEZ (Anthony Alonzo) and ENRICO S. SERRANO.

WHEREAS, as presently constituted, the 2nd district of Quezon City is divided into two (2) separate areas for administrative purposes, one of which is composed of the thirteen (13) barangays comprising the Novaliches District and the other is made up of all the barangays not embraced within the confines of the former,

WHEREAS, pursuant to this administrative scheme, the Tricycle Operators and Drivers Association (TODA) operation in the Novaliches area is separately administered by a separate Tricycle Regulation Unit (TRU) administrative machinery at the Novaliches District Center while the TODA operation in those barangays not covered by the Novaliches area is directly administered by the TRU at the Quezon City Hall;

WHEREAS, under the foregoing set-up, the TODAS within the Novaliches area are not given due representation in the Quezon City Tricycle Franchising Board considering that the 2nd District is solely represented by a representative coming from the TODAS operating outside the Novaliches area;

WHEREAS, this seeming discrepancy must be put in its proper perspective by affording appropriate remedial measures thereto.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. The 2nd District of Quezon City is hereby constituted into two (2) separate areas for purposes of Tricycle Operators and Drivers Association (TODA) representation in the Quezon City Tricycle Franchising Board, to wit:

1. District II-A (TODA) - to be composed of the thirteen (13) barangays comprising the Novaliches District Area.
2. District II-B (TODA) - to be composed of all the other barangays not embraced within the Novaliches District Area.


