ORDINANCE NO. SP- 489, S-97

AN ORDINANCE DESIGNATING TWO HUNDRED (200) SQUARE METERS OF GOVERNMENT LAND COVERED BY TCT NO. RT-28528 OWNED BY THE CITY GOVERNMENT WITH AN AREA OF NINE THOUSAND SIX HUNDRED FORTY EIGHT (9,648) SQUARE METERS LOCATED AT THE OPEN SPACE AT BARANGAY TALIPAPA TO BE UTILIZED AS THE SITE OF THE PROPOSED CENTRAL POLICE STATION 3 HEADQUARTERS BUILDING.

WHEREAS, the lease contract over the building housing the Police Station 3 Headquarters of the Central Police District located at Sangandaan, Quezon City, is about to expire;

WHEREAS, the transfer of Station 3 to another venue is detrimental to the security, peace and order situation in the area;

WHEREAS, the presence of the police headquarters is most effective deterrent to lawless elements in the area of more than five hundred (500) establishments and residential subdivisions and where factories, markets, hardwares, commercial centers, shops, schools and others are operating;

WHEREAS, in its Resolution No. 231, S-95, The Sanggunian Barangay of Talipapa, Quezon City, is requesting the Honorable Ismael A. Mathay, Jr., City Mayor, Quezon City, to designate a portion of the eight hundred (800) square meters of City government property currently occupied by Tandang Sora Health Center located along Quirino Highway, Barangay Talipapa, as the site for the proposed construction of Police Station 3 of the Central Police District Command;

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN
SESSION ASSEMBLED:


SECTION 1. There is hereby designated Two Hundred (200) Square Meters of government land covered by Transfer Certificate of Title No. RT-28528 owned by the City government with an area of Nine Thousand Six Hundred Forty Eight (9,648) square meters located at the open space at Barangay Talipapa to be utilized as the site of the proposed Central Police Station 3 Headquarters building.

SECTION 2. This Ordinance shall take effect upon its approval.
