## ORDINANCE NO. SP-492, S-97

AN ORDINANCE SETTING THE GUIDELINES FOR THE REPRESENTATION OF THE TRICYCLE OPERATORS AND DRIVERS ASSOCIATIONS (TODA) IN THE QUEZON CITY TRICYCLE FRANCHISING BOARD.

WHEREAS, operators and drivers of tricycles in Quezon City are represented in the Quezon City Tricycle Franchising Board thru their respective federation district representatives pursuant to Section 5 (6) of Ordinance No. SP-15, S-92, as amended;

WHEREAS, a perusal on the provisions of said ordinance shows that the criteria and manner of selection as well as the term of office of such TODA representatives are not clearly specified, thus creating a situation whereby a TODA representative may be sitting as member of the Quezon City Tricycle Franchising Board, but is no longer carrying the trust, confidence, voice and support of the TODA members he is suppose to represent;

WHEREAS, to clear the foregoing predicament, a guideline for TODA representation in the Quezon City Tricycle Franchising Board must be laid down in order that such representation will be made more definitive and more reflective of the true sentiments of the majority of the TODA members;

## NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. The Tricycle Operators and Drivers Associations (TODA) representative to the Quezon City Tricycle Franchising Board provided under Section 5 (6) of Ordinance No. SP-15, S-92, as amended, shall be the TODA federation president in each of the four (4) districts of Quezon City except second district which has two representations, who shall hold office for a term of one (1) year starting January 1 each year.

For purposes of this ordinance, a TODA federation shall be considered as comprising of all the TODA presidents and legitimate tricycle franchisees in a given district who shall, on the 2nd Sunday of December of each year, elect from among themselves the TODA representative to the Quezon City Tricycle Franchising Board.

Should a TODA Federation President dies, resigns or be convicted of a crime the TODA Federation Vice-President shall succeed and shall hold office only for the unexpired term of his predecessor.

A TODA representative who is busted from his office as president of the TODA federation which he represents for causes other than death, resignation, or conviction of a crime shall remain as a member of the Board until the expiration of his term.

The incumbent TODA representatives now sitting as members of the Board shall continue as such members until December 31, 1997.

SECTION 2. All ordinances, rules, regulations, or parts thereof, and other issuances not consistent with the provisions of this Ordinance are hereby repealed or modified accordingly.

SECTION 3. This Ordinance shall take effect immediately upon its approval.
