ORDINANCE NO. SP- 501 , S-97

AN ORDINANCE ESTABLISHING A DEPARTMENT OF ALUMNI AFFAIRS IN ALL PUBLIC SECONDARY AND PRIMARY SCHOOLS IN QUEZON CITY AS PART OF THE EDUCATIONAL INSTITUTION.

WHEREAS, an alumni association is organized primarily to serve as a link for civic and social interaction between the school, the graduates, and the community;

WHEREAS, although loosely interrelated, the interplay of these three forces oftentimes results in the enhancement of the cultural, social, and civic consciousness of the general public;

WHEREAS, in line with the foregoing, there is a need to foster a stronger bond between the school and the alumni association in order to bring about a firmer partnership commitment in their quest for developmental goals not only for themselves but the community as well.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. There is hereby established a Department of Alumni Affairs which shall have the functions of monitoring developments, supervision of alumna and alumni association in all public secondary and primary schools in Quezon City as part of the educational institution which shall be under the supervision of the school principals concerned.

SECTION 2. The Department of Alumni Affairs, a recognized Alumni Association shall have an assigned permanent office in any room of the school upon arrangement with the school principal for efficient management of the affairs thereof.


SECTION 3. The City Government, thru its City Mayor and the City Secretary of the City Council, may provide assistance, financial or otherwise, to the Department of Alumni Affairs or to the recognized Alumni Association for the effective realization of the purpose for which it was created.

SECTION 4. This Ordinance shall take effect upon its approval.
