ORDINANCE NO. SP- 555 -S-97

AN ORDINANCE EXTENDING FINANCIAL ASSISTANCE TO THE VICTIMS OF THE FIRE CONSISTING OF SEVERAL FAMILIES WHOSE HOUSES AT 87 KALAYAAN AVENUE, BARANGAY CENTRAL, DISTRICT IV, QUEZON CITY, WERE BURNED ON AUGUST 30, 1997, AT THE SUM OF TWO THOUSAND PESOS (P2,000.00) FOR EACH HOUSE-OWNER AND ONE THOUSAND PESOS (P1,000.00) FOR EACH HOUSE-RENTER/SHARER WHICH SHALL BE TAKEN FROM THE CALAMITY OR EMERGENCY FUND OF THE CITY GOVERNMENT OR FROM ANY AVAILABLE FUNDS OF THE CITY TREASURY.

WHEREAS, the Quezon City Council is empowered under Section 485 (a), (1), (iv) of R.A. 7160 otherwise known as the Local Government Code of 1991, to "adopt measures to protect the inhabitants of the City from the harmful effects of man-made or natural disasters and calamities, and to provide relief services and assistance for victims during and in the aftermath of said disasters or calamities, and their return to productive livelihood following said events.";

WHEREAS, as reported by the Social Services Development Department (SSDD), a fire occurred at 87 Kalayaan Avenue, Barangay Central, Quezon City, on August 30, 1997;

WHEREAS, because of this unfortunate incident, our constituents, who are presently in makeshift dwellings can only hope for and pray for the early release of financial assistance from the City government;

WHEREAS, these unfortunate fire victims need the assistance of the City government in the form of financial aid to defray the cost of building materials for the reconstruction of their houses, purchase of foods, clothing and other necessary expenses in the amount of Two Thousand Pesos (P2,000.00) for each house-owner and One Thousand Pesos (P1,000.00) for each house-renter/sharer;

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN



SECTION 1. The Quezon City government hereby extends financial assistance to the fire victims of 87 Kalayaan Avenue, Barangay Central, Quezon City, on August 30, 1997, at Two Thousand Pesos (P2,000.00) for each house-owner and One Thousand Pesos (P1,000.00) for each house-renter/sharer.

SECTION 2. The Social Services Development Department shall submit a report that will state the exact number of families thus affected, and which shall serve as a basis for the amount to be appropriated and released immediately to the concerned agency to provide the necessary financial assistance to all identified fire victims, which shall be taken from the calamity or emergency fund of the City government for the purpose.


SECTION 3. The Office of the City Engineer and the Social Services Development Department are hereby enjoined to coordinate as facilitators in the orderly implementation hereof.

SECTION 4. This Ordinance shall take effect upon its approval.
