ORDINANCE NO. SP- 558 , S-97

AN ORDINANCE AUTHORIZING THE HONORABLE ISMAEL A. MATHAY, JR., MAYOR OF QUEZON CITY, TO CONSTITUTE AND APPOINT THE CHAIRMEN AND MEMBERS OF THE SANGGUNIANG KABATAAN (SK) OF THE NEWLY CREATED BARANGAYS PASONG PUTIK PROPER, GREATER LAGRO, AND NORTH FAIRVIEW, NOVALICHES, QUEZON CITY.

WHEREAS, pursuant to City Ordinance No. SP-439, S-96, the former Barangay Pasong Putik was split into three (3) separate and independent barangays, namely, Pasong Putik Proper, Greater Lagro, and North Fairview, approved in a plebiscite held on December 8, 1996, and their respective officials, subsequently qualified during the last barangay elections held in May 1997;

WHEREAS, the splitting of Barangay Pasong Putik rendered its Sangguniang Kabataan inoperative as it could not function as such for any of the three barangays;

WHEREAS, it is imperative that the Sangguniang Kabataan of the three (3) newly created barangays be constituted to attend to the needs and welfare of the youths in the said barangays;

WHEREAS, Section 14 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that, "when a new local government unit is created its corporate existence shall commence upon the election and qualification of its punong barangay and a majority of the members of its sanggunian unless some other time is fixed therefor by the law or ordinance creating it.";

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:


SECTION 1. The Honorable Ismael A. Mathay, Jr., Mayor of Quezon City, is hereby authorized to constitute the Sangguniang Kabataan (SK) of the newly created Barangays Pasong Putik Proper, Greater Lagro, and North Fairview, in Novaliches, Quezon City, and appoint their Chairmen and Council Members; Provided, that those incumbent SK Council members when Barangay Pasong Putik was split, shall remain in office or appointed in the Sangguniang Kabataan where they reside.


SECTION 2. These appointed Chairmen and Members of the Sangguniang Kabataan of Barangays Pasong Putik Proper, Greater Lagro, and North Fairview, shall serve as such until their successors shall have been duly elected and qualified in the next Sangguniang Kabataan elections.

SECTION 3. This Ordinance shall take effect upon its approval.
