ORDINANCE NO. SP- 597 - S-97

AN ORDINANCE AMENDING CERTAIN PROVISIONS OF ORDINANCE NO. SP-492, S-97, ON THE ELECTIONS OF TRICYCLE OPERATORS AND DRIVERS ASSOCIATION (TODA) REPRESENTATIVES TO THE TRICYCLE FRANCHISING BOARD.

WHEREAS, there is a need to update certain provisions of Ordinance No. SP-492, S-97, on the elections of Tricycle Operators and Drivers Association (TODA) representatives to the Quezon City Tricycle Franchising Board;

WHEREAS, in the interest of public service while in transition towards mandated representation of the sectors coming from the Tricycle Operators and Drivers Association the very essence and spirit of Ordinance No. SP-492, S-97, it is necessary that incumbent TODA representatives should have a limit of their terms and mandates in their respective representations;

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. The first and last paragraphs of Section 1 of Ordinance No. SP-492, S-97 are hereby amended, to read as follows:

"SECTION 1. The Tricycle Operators and Drivers Associations (TODA) representatives to the Quezon City Tricycle Franchising Board provided under Section 5 (6) of Ordinance No. SP-15, S-92, as amended, shall be the TODA federation president in each of the four (4) districts of Quezon City except second district which has two representations, who shall hold office for a term of one (1) year starting January 1 of each year FOR A MAXIMUM OF THREE (3) CONSECUTIVE TERM.

The incumbent TODA representatives now sitting as members of the Board shall continue as such members until December 31, 1997, <u>UNLESS ELECTED BY THE TODA PRESIDENT IN HIS DISTRICT OR AREA OF REPRESENTATION IN THE CASE OF SECOND DISTRICT."</u>
