AN ORDINANCE RE-CLASSIFYING THE DEAD-END PORTION OF ASTORIA STREET CORNER RIVERDALE STREET IN BARANGAY ST. IGNATIUS FROM ROAD LOT TO OPEN SPACE.

WHEREAS, Barangay St. Ignatius Council Resolution No. 030-98 calls for the transfer of the Barangay BSDO barracks and Office from Riviera alley to the dead end corner of Astoria Street, corner Riverdale Street;

WHEREAS, the Urban Route Project Office of the Department of Public Works and Highways has declared that Astoria Street will not anymore be used as exit to E. Rodriguez Avenue due to its steep incline;

WHEREAS, the dead-end of Astoria Street as site of the BSDO barracks is intended to discourage "Akyat Bahay Gang" members from entering St. Ignatius Village by climbing over the perimeter wall;

WHEREAS, the Honorable City Mayor, Ismael A. Mathay, Jr., has approved the construction of the Barangay BSDO barracks on the subject Astoria Street;
