## ORDINANCE NO. SP. 666 3 5-98

AN ORDINANCE RENAMING THE STREET/ALLEY CONNECTING KATIPUNAN AVENUE TO JOSE P. LAUREL STREET, BETWEEN TOMAS CASTRO AND RAJAH MATANDA STREETS, IN BARANGAY MILAGROSA AS SUNRISERS ALLEY.

Introduced by Councilors JORGE L. BANAL and EMILIO G. TAMAYO.

Co-Introduced by Councilors Connie S. Angeles, Eufemio C. Lagumbay, Cesar A. Dario, Jr., Franz S. Pumaren, Bayani V. Hipol, Joseph Peter S. Sison, Moises S. Samson and Godofredo T. Liban II.

WHEREAS, Section 13, (c) (2) of R.A. 7160, the Local Government Code of 1991, provide that the Sangguniang Panlungsod may change the names of "city, municipal and barangay roads, avenues, boulevards, thoroughfares and bridges";

WHEREAS, an unnamed alley/street in Barangay Milagrosa need to be assigned a name for identification purposes for facility of identification/location in the delivery of mails and other purposes;

WHEREAS, Sunrisers Group Philippines, Inc., a non-profit, socio-civic organization devoted to physical fitness and the propagation of brotherhood in the Project 4 area, enjoys a prestigious history of having prominent names in government and business as among those who have had occupied its officers and membership roll;

## NOW, THEREFORE.

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. The alley/street connecting Katipunan Avenue to Jose P. Rizal Street in between Tomas Castro and Rajah Matanda Streets in Barangay Milagrosa, Project 4, is hereby named as "Sunrisers Alley".

SECTION 2. A copy of this Ordinance shall be sent to the Office of the President, the Honorable Congressman of the Third District, this City, and the Postmaster General, Philippine Postal Corporation, as required under Section 13 (h) of R.A. 7160.
