ORDINANCE NO. SP- 686 , S-98

AN ORDINANCE AUTHORIZING THE BARANGAY COUNCIL OF BARANGAY FAIRVIEW, QUEZON CITY, TO INSTALL OR CONSTRUCT MANNED OUTPOSTS OR GATES AT STRATEGIC ENTRANCES TO THE BARANGAY FOR SECURITY AND CONTROL PURPOSES IN LINE WITH THE PROVISIONS OF SECTIONS 16 AND 21 OF THE REPUBLIC ACT NO. 7160, OTHERWISE KNOWN AS THE "LOCAL GOVERNMENT CODE OF 1991."

Introduced by Councilor GODOFREDO T. LIBAN II.

WHEREAS, the people residing in East Fairview, Barangay Fairview, Quezon City, has addressed an urgent petition to the Barangay Council of the said Barangay, requesting authority to install or construct manned outposts or gates at strategic entrances to the barangay for security and control purposes;

WHEREAS, the Barangay Council, through its Punong Barangay, has given due course to the petition and enacted Barangay Ordinance No. 02, Series of 1997, authorizing the installation or construction of manned outposts and gates at the following places, to wit:

1. Viceroj corner Fairview Avenue
2. Winston between Fairview Avenue and Dunhill Street
3. Marlboro between Fairview Avenue and Dunhill Street
4. Winston Pearl
5. Windsor corner Winston, and
6. Windsor corner Peacock Street

WHEREAS, this August Body finds the sentiments of the people residing in Barangay Fairview worthy of its consideration as it believes that the construction or installation of manned outposts or gates at strategic entrances of the Barangay would discourage the criminally inclined to perpetrate their criminal designs especially at night, knowing that these manned outposts or gates will militate against their depredations;

WHEREAS, manned outposts or gates at strategic entrances of Barangay Fairview will redound to the safety, security and convenience, not only of the inhabitants thereof, but also of the commuting public at large;


NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:


SECTION 1. The Barangay Council of Barangay Fairview, Quezon City, is hereby authorized to install or construct manned outposts or gates at strategic entrances to the barangay for security and control purposes in line with the provisions of Sections 16 and 21 of the Republic Act No. 7160, otherwise known as the "Local Government Code of 1991."

SECTION 2. This Ordinance shall take effect upon its approval
