AN ORDINANCE APPROVING THE SUBDIVISION PLAN OF LOT 106, PSU-24733, CONTAINING AN AREA OF ONE HUNDRED FIFTY-THREE THOUSAND SEVEN HUNDRED FORTY SEVEN (153,747) SQUARE METERS, COVERED BY TRANSFER CERTIFICATE OF TITLE NUMBERED RT-36076 (95943) OF THE REGISTRY OF DEEDS OF QUEZON CITY, REGISTERED IN THE NAME OF THE QUEZON CITY GOVERNMENT, AND LOCATED AT BARANGAY BAGONG SILANGAN, QUEZON CITY, AS APPLIED FOR BY BARANGAY BAGONG SILANGAN HOMEOWNERS' ASSOCIATION, INC., SUBJECT TO THE CONDITIONS PRESCRIBED UNDER QUEZON CITY ORDINANCE NO. SP-56, S-92 AND BATAS PAMBANSA BLG. 220.

WHEREAS, the Quezon City government is the registered owner of a real estate property identified as Lot 106, Psu-24733, covered by TCT No. RT-36076 (95943) of the Registry of Deeds of Quezon City, containing an area of One Hundred Fifty-Three Thousand Seven Hundred Forty Seven (153,747) square meters, and located at Barangay Bagong Silangan, Quezon City;

WHEREAS, in compliance to and in conformity with the MEMORANDUM OF AGREEMENT dated February 20, 1993, executed between the Quezon City government and the Barangay Bagong Silangan Homeowners' Association, Inc., the relocation, consolidation and subdivision survey of subject lot were undertaken;

WHEREAS, the City government, thru the Honorable City Mayor Ismael A. Mathay Jr., on April 6, 1998 approved the Subdivision Plan covering Lot 106, Psu-24733 and accepted by the Barangay Bagong Silangan Homeowners' Association, Inc., represented by its President, Mr. Marcelo A. Valdez;
