ORDINANCE NO. SP- 780 , S-99

AN ORDINANCE REQUIRING THE 142 BARANGAYS TO SET ASIDE 5% OF THE ANNUAL BUDGET FOR THE COMPUTERIZATION OF ITS BARANGAY OPERATIONS BY THE ESTABLISHMENT OF MANAGEMENT INFORMATION SYSTEM (MIS) IN FISCAL YEAR 2000.

WHEREAS, all barangays are required to keep an update of all inhabitants of the barangay containing the following items of information: name, address, place of birth, sex, civil status, citizenship, occupation and such other items of information as may be prescribed by law or ordinance and submit a report on the actual number of barangay residents;

WHEREAS, the barangay is also required to assist in the preparation of all necessary forms for the conduct of barangay elections, initiatives, referenda or plebiscites, in coordination with the COMELEC;

WHEREAS, there is a need to maintain records in the barangay such as the list of actual residents, list of registered voters, list of accredited associations and organizations and list of establishments conducting business activities within the territorial jurisdiction of the barangay for the purpose of complying with the requirements of the law, request for a certification of clearance from individuals, corporations and other government agencies, including monitoring purpose;"

WHEREAS, to be accurate, correct and truthful in the issuance of reports, clearances and certifications the aid of a sophisticated computer technology is necessary to facilitate and effectively meet the requirements or demands of the general public as well as to be updated and kept abreast with the current trends of computerized operations through Management Information System popularly known as MIS;


NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN
SESSION ASSEMBLED :


SECTION 1. The One Hundred Forty-Two (142) Barangays are hereby
required to set aside five percent (5%) of the Annual Budget for the computerization
of its barangay operations by the establishment of Management Information System
(MIS) in fiscal year 2000.

SECTION 2. This ordinance shall take effect upon its approval.
