ORDINANCE NO. SP- 773 - S-99

AN ORDINANCE PROHIBITING THE USE OF INCANDESCENT BULBS WHICH PRODUCE YELLOWISH AND COLORED GLOW AND ANY ATTACHED LUMINOUS AND REFLECTORIZED MATERIALS IN ALL PRIVATE AND PUBLIC MARKETS, FLEA MARKETS, TALIPAPA STALLS AND OTHER SIMILAR ESTABLISHMENTS SELLING FRESH VEGETABLES, FISH AND/OR MEAT AND PROVIDING PENALTIES FOR VIOLATION THEREOF.

WHEREAS, Section 458, (a) (5) (iv) of Republic Act 7160, otherwise known as the Local Government Code of 1991, authorizes the sangguniang panlungsod, to wit;

"Regulate the preparation and sale of meat, poultry, fish, vegetables, fruits, fresh dairy products, and other food-stuffs for public consumption."

WHEREAS, incandescent bulbs which produce a yellowish and colored glow and any attach luminous and reflectorized materials create some unusual effect on the state of condition of vegetables, fish and/or meat in all markets and vending stalls;

WHEREAS, there is a need for the city government to find ways and means to protect consumers from vendors who sell unfresh and/or rotten vegetables, fish and/or meat;

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. The use of bulbs which produce a yellowish and colored glow and any attached luminous and reflectorized materials is prohibited in all private and public markets, flea markets, talipapa stalls and other similar establishments selling fresh vegetables, fish and/or meat.

SECTION 2. Only daylight fluorescent lamps that produce clear and colorless lights shall be used in all private and public markets, flea markets, talipapa stalls and other similar establishments selling fresh vegetables, fish and/or meat.


SECTION 3. Any person who violates any provision of this Ordinance shall suffer the following penalty:

- First Offense - Fine of P 500.00
- Second Offense - Fine of P 1,000.00
- Third Offense - Revocation of Business Permit of concerned Private Markets; and  
- Revocation of Business Permit and Certificate of Awards of stall holders concerned in Public Markets


SECTION 4. The Market Administrator is hereby authorized to strictly implement/enforce the provision of this Ordinance. He shall recommend to the Business Permits and Licensing Office (BPLO) the revocation of business permit of market and stall vendors who have violated for the third time the provision of this Ordinance.

SECTION 5. This Ordinance shall take effect upon its approval.
