ORDINANCE NO. SP- 774 , S-99

AN ORDINANCE AMENDING ORDINANCE NO. SP-753, S-98, BY CHANGING THE ACCOUNT TITLE "OTHER SERVICES" (BURIAL) TO "AWARDS AND INDEMNITIES" UNDER ITEM MAINTENANCE AND OTHER OPERATING EXPENSES (MOOE), BUDGET OF THE CITY MAYOR.

WHEREAS, under the General Budget of the Quezon City government for the year 1999 as authorized under City Council Ordinance No. 753, S-98, the financial assistance intended for various burial claims of bereaved families of barangay officials and PNP Officers were charged against the account "Other Services (Burial)" during previous fiscal years;

WHEREAS, the resident auditor of Quezon City rendered an opinion that such claim can no longer be allowed nor charged under the said account since the appropriate account wherein such kind of claims can be charged shall be under account "Awards and Indemnities";

WHEREAS, there is a need to amend and change the account title "Other Services (Burial)" to "Awards and Indemnities" to conform with the correct and appropriate account titles in consonance with the General Accounting and Auditing Manual (GAAM);

WHEREAS, there are several and various burial claims pending for consideration that require immediate and appropriate action in order to ease the burden of the bereaved families caused by the sudden and untimely death of the head of the family;

NOW, THEREFORE,


BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. The account title "Other Services (Burial)" is hereby amended and changed to "Awards and Indemnities" under item Maintenance and Other Operating Expenses (MOOE), Budget of the City Mayor.


