## ORDINANCE NO. SP- 777 S-99

AN ORDINANCE DECLARING BOTH SIDES OF R. ALVERO, F. DELA ROSA, E. ABADA AND B. GONZALES STREETS, ALL OF BARANGAY LOYOLA HEIGHTS, THIS CITY, AS NO PARKING AREAS FOR ALL TYPES OF VEHICLES FROM 6:00 A.M. TO 6:00 P.M., FROM MONDAY TO FRIDAY, EXCEPT FOR TRICYCLE TERMINAL AREAS FOR PUBLIC CONVEYANCE.

WHEREAS, the construction of Mass Railway Transit (MRT) along Auro ra Blvd. increased the volume of traffic along Circumferential Road (C-5) and its neighboring secondary roads and congestion of traffic occurs when all types of vehicles are parked on both sides of city-owned streets located at Barangay Loyola Heights, namely: R. Alvero, F. Dela Rosa, E. Abada and B. Gonzales Streets;

WHEREAS, the sangguniang barangay of Barangay Loyola Heights, on November 19, 1998, passed resolution No. 57, Series of 1998 urging the Quezon City Council to enact an ordinance declaring both sides of the aforementioned streets as no parking areas for all types of vehicles.

## NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. Both sides of R. Alvero, F. Dela Rosa, E. Abada and B. Gonzales Streets all located within Barangay Loyola Heights are hereby declared as no parking areas for all types of vehicles from 6:00 A.M. to 6:00 P.M., Monday to Friday, except for tricycle terminal areas for public conveyance.

SECTION 2. The Department of Public Order and Safety shall prepare and install traffic informative signs along the streets of R. Alvero, F. Dela Rosa, E. Abada and B. Gonzales all located within Barangay Loyola Heights, this City.

SECTION 3. The traffic enforcers of the Department of Public Order and Safety, in coordination with the Traffic Management Group of the Metropolitan
