ORDINANCE NO. SP- 782 - \$-99

AN ORDINANCE APPROVING THE MASTER PLAN OF THE SEGREGATED ONE HUNDRED EIGHTY FOUR (184) HECTARES OF THE NATIONAL GOVERNMENT CENTER (NGC) WEST SIDE FOR DEVELOPMENT AND DISPOSITION INTO A HOUSING COMMUNITY AND OTHER AMENITIES, AS SUBMITTED BY THE NATIONAL GOVERNMENT CENTER HOUSING PROJECT AND THE HOUSING AND URBAN DEVELOPMENT COORDINATING COUNCIL (NGCHP-HUDCC) IN COMPLIANCE WITH THE LEGAL MANDATES PROVIDED UNDER PRESIDENTIAL PROCLAMATION NO. 137, AS AMENDED BY PROCLAMATION NO. 248 AND MEMORANDUM ORDER NO. 151 AND MEMORANDUM ORDER NO. 391.

WHEREAS, the Master Plan for the One Hundred Eighty-Four (184) hectares of the National Government Center West side will unify the One Thousand Nine Hundred (1,900) titles in favor of the Republic of the Philippines and the One Hundred Fifty Eight (158) individual associations with varying individual community development plans (CDP) in the subject One Hundred Eighty-Four (184) hectares of land;

WHEREAS, the subject Master Plan will involve and benefit forty thousand (40,000) families in the said fourteen (14) hectares of land, encompassing within its territorial jurisdiction portions of Barangay Holy Spirit and Barangay Commonwealth, who are envisioned to live in a community with solidarity and cooperation and would no longer sell their rights, including their house and lot to opportunists;

WHEREAS, the said Master Plan will fast track the implementation of not only the Controlled Zone thereat but also it will be the basis in approving the individual community plans of the family beneficiaries in subject land;
