RESOLUTION NO. 7 8/6 , 5-99

AN ORDINANCE ALLOWING ONE-SIDE PARKING IN CERTAIN STREETS OF BARANGAY E. RODRIGUEZ, SR., AND PROVIDING PENALTIES FOR VIOLATION THEREOF.

Introduced by Councilor JULIAN M.L. COSETENG Co-Introduced by Councilors Jorge L. Banal, Godofredo T. Liban II, Ma. Fresca M. Biglang-awa, Vincent P. Crisologo, Bayani V. Hipol, Elizabeth A. Delarmente, Antonio L. Sioson, Winston "Winnie" T. Castelo and Alma F. Montilla.

WHEREAS, Section 16 of the Local Government Code provides that:

"Every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient governance, and those which are essential to the promotion of the general welfare. Within their respective territorial jurisdictions, local government units shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, enhance the right of the people to a balanced ecology, encourage and support the development of appropriate and self-reliant scientific and technological capabilities, improve public morals, enhance economic prosperity and social justice, promote full employment among their residents, maintain peace and order, and preserve the comfort and convenience of their inhabitants".

WHEREAS, the barangay government of E. Rodriguez, Sr., passed Barangay Resolution No. 46, S-97, entitled "A resolution strongly urging the City Council to pass an Ordinance allowing only one-side parking in certain streets of Barangay E. Rodriguez, Sr., with penalties in violation thereof,

WHEREAS, use of both sides of the streets for parking creates traffic bottlenecks, unnecessary delays and loss of precious man-hours considering the width of the road and the volume of vehicles passing through Barangay E. Rodriguez, Sr.:

WHEREAS, residents of the area are affected by the irresponsible parking of vehicles on both sides of the streets even on driveways especially by non-residents of Barangay E. Rodriguez, Sr.;

WHEREAS, the Sangguniang Barangay enacted an ordinance regulating the parking of vehicles in certain streets of the Barangay, and allowing one side parking in answer to various complaints of residents who are affected by irresponsibly parked vehicles on both sides of the streets even on driveways;

WHEREAS, the Sangguniang Barangay requested the Department of Public Order and Safety (DPOS), Quezon City for comments and suggestions, getting response in return with suggestion, that one side parking be transferred every Fifteen (15) days so that the residents on both sides of the road can enjoy the advantages of the ordinance;

WHEREAS, the said ordinance was forwarded to the City Council through the City Secretary, for review, but during the hearing held last August 15, 1997 of the Special Review Committee on Barangay Ordinances, the committees ruled that since the roads mentioned in the ordinance are all City streets, it is beyond the power of the barangay to regulate the use thereof, thus the need for the above mentioned resolution;

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

- SEC. 1. TITLE This ordinance shall be known as the "Parking Ordinance of Barangay E. Rodriguez, Sr."
- SEC. 2. DEFINITION : ILLEGAL PARKING Any parked vehicles within the prohibited zones as indicated by signs and special parking marks/signals shall be deemed illegally parked vehicles.
- SEC. 3. STREETS COVERED The following city streets in Barangay E. Rodriguez Sr. are hereby declared as one side parking streets.
 - a) Montreal Street
 - b) Annapolis Street
 - c) St. Mary Street
 - d) Westpoint Street
 - e) Imperial Street
 - f) Cambridge Street
 - g) Purdue Street
 - h) Oxford Street
 - i) Yale Street
 - j) Stanford Street
 - k) Harvard Street
 - 1) Columbia Street
 - m) and all streets located within the territorial jurisdiction of the Barangay.

One side parking will be allowed from the 1st 15 days of the month after which from the 16th up to the last day of the month the one side parking shall be shifted to the other side of the street.

- SEC. 5. REPEALING CLAUSE Any resolution, ordinance, local rules or regulations inconsistent with the provision of this ordinance shall be considered repealed and/or modified accordingly.
- SEC. 6. SAVING CLAUSE If, for any reasons, any part or provision of this ordinance shall be held unconstitutional or invalid, other parts or provisions thereof which are not affected thereby shall continue to be in full force and effect.

SEC. 7. EFFECTIVITY - This Ordinance shall take effect upon its approval.

PENALTIES - Any violation of this ordinance shall be punished by a fine of not less than Two Thousand Pesos (P2,000.00) but not more than Five Thousand Pesos (P5,000.00) and vehicles illegally parked shall be towed by any accredited Metropolitan Manila and Development Authority (MMDA) or Quezon City traffic towing crew.
