## ORDINANCE NO. SP-\_787 -- \$-99

AN ORDINANCE FURTHER AMENDING SECTION 5 OF ORDINANCE NO. SP-15, S-92, AS AMENDED BY ORDINANCE NO. SP-351, S-95, AND ORDINANCE NO. SP-479, S-96, SO AS TO INCLUDE ALL OTHER CITY COUNCILORS OF THE DISTRICT CONCERNED AND THE HEAD OF THE DEPARTMENT OF PUBLIC ORDER AND SAFETY (DPOS) AS REGULAR MEMBERS OF THE QUEZON CITY TRICYCLE FRANCHISING BOARD.

WHEREAS, Council representation to the Tricycle Franchising Board is not proportionate according to the respective district council representation;

WHEREAS, there is a need to include the representation of the Department of Public Order and Safety (DPOS) in the Tricycle Franchising Board on matters of traffic, terminals and other related issues on public order and safety;

WHEREAS, to resolve the unproportionate representation to the Tricycle Franchising Board, all Councilors from the District concerned and the Chief of the DPOS shall now be constituted as members of the Tricycle Franchising Board;

## NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. Section 5 of Ordinance No. SP-15, S-92, as amended by Ordinance No. SP-351, S-95, and Ordinance No. SP-479, S-96, is hereby further amended, to read as follows:

"Section 5. The Quezon City Tricycle Franchising Board under the Sangguniang Panlungsod is hereby created to be composed of the following:

1. The Chairman of the Committee on Transportation and Communication, as Chairman.

- 3. The Chairman of the Committee on Barangay Affairs and Community Relations, as member.
- 4. The Head of the Department of Public Order and Safety, as member.
- 5. The Chief of Tricycle Regulation Unit, as member.
- 6. The Federation District Representative of the concerned District Tricycle Operators and Drivers Association, as member.

SECTION 2. The presence of a member of the City Council in the quorum is sufficient to transact the business of the Board.

SECTION 3. There shall be a Board Secretary who shall, at the same time, be the Chief of Office to attest to all Board resolutions and sign all the warrants.

SECTION 4. This Ordinance shall take effect immediately upon its approval
