ORDINANCE NO. SP- 789 -99

AN ORDINANCE AMENDING ORDINANCE NO. SP-602, S-97, CREATING THE POSITION OF SANITARY ENGINEER III UNDER THE SANITATION SERVICES DIVISION, QUEZON CITY HEALTH DEPARTMENT.

WHEREAS, under the duly approved Quezon City Ordinance No. SP-602, S-97, one (1) plantilla position of Sanitary Engineer III (Salary Grade 19) under the Sanitation Services Division, Quezon City Health Department, was created to provide technical supervision on water supply sanitation;

WHEREAS, on the basis of the existing compensation and position classification guidelines and the submitted duties and responsibilities of the position created in said Ordinance, the Department of Budget and Management (DBM) classified the same as Engineer III with the same salary grade;

WHEREAS, to conform with the said compensation and position classification guidelines, there is a need to amend the said Ordinance by rectifying the position title of Sanitary Engineer III to Engineer III;

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. Ordinance No. SP-602, S-97 is hereby amended by changing the plantilla position title of Sanitary Engineer III to Engineer III under the Sanitation Services Division, Quezon City Health Department.
