AN ORDINANCE APPROVING THE SUBDIVISION PLAN OF RESIDENTIAL (BP BLG. 220) WITH 29-LOTS, COMMUNITY HOUSING PROJECT MORTGAGE PROGRAM, CONTAINING AN AREA OF ONE THOUSAND TWO HUNDRED FIFTY-ONE (1,251) SQUARE METERS., COVERED BY TRANSFER CERTIFICATES OF TITLE NUMBERED RT-73510 & 104689 OF THE REGISTRY OF DEEDS OF QUEZON CITY, REGISTERED IN THE NAMES OF BENJAMIN C. PINEDA AND MANOLO G. PINEDA, RESPECTIVELY, (VENDORS), AND LOCATED AT LOTS 1 & 17, BLOCK 21, PCS-2874; KAGAWAD STREET, BILL STREET CORNER RESOLUTION STREET, DOLOR ESTATE, BARANGAY BATASAN HILLS, QUEZON CITY, METRO MANILA, AS APPLIED FOR BY THE SAMAHAN NG UGNAYANG PANTAO SA TALANAY, INC.
