ORDINANCE NO. ~~SP-791~~ S-99

AN ORDINANCE AMENDING SECTION 1 OF ORDINANCE NO. SP-613, S-97, SO AS TO MODIFY THE TRICYCLE ROUTES ESTABLISHED THEREIN.

WHEREAS, the primordial reason for the enactment of Ordinance No. SP-613, S-97, was to apportion into three (3) strategic areas with their corresponding Route Measured Capacity (RMC) the tricycle routes established within Barangay Sta. Monica, District II, Quezon City, covering Regalado Street, Commonwealth Avenue to Palmera Homes Subdivision, North Ridge Park Subdivision and vice versa, to be serviced separately by Palmera Homes Tricycle Operators and Drivers Association (PH TODA), Palmera Homes IV Tricycle Operators and Drivers Association (PHIV TODA), and North Ridge at Palmera Tricycle Operators and Drivers Association (NAPATODA);

WHEREAS, due to an oversight, Ordinance No. SP-613, S-97, inadvertently failed to clearly delineate the routes and the areas assigned to each of the servicing tricycle associations thereat, thereby causing a lot of misunderstanding and confusion among all the affected parties thereto;

WHEREAS, in view of the foregoing, there is an imperative need to amend such ordinance in order to reflect the real intendment thereof;

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. Section 1 of Ordinance No. SP-613, S-97, is hereby amended, to read as follows:

"SECTION 1. The following tricycle routes and their respective Route Measured Capacity (RMC) are hereby established:

From Palmera Homes I, II, III to Geneva Garden, Commonwealth Avenue, Athertone Street and vice versa, within Barangay Sta. Monica, District II, Quezon City, with RMC of 100 units the same to be serviced by Palmera Homes Tricycle Operators and Drivers Association (PH TODA).

From Palmera Homes IV to Labayane Street, Commonwealth Avenue, Athertone Street and vice versa, with RMC of forty (40) units, the same to be serviced by Palmera Homes IV Tricycle Operators and Drivers Association (PHIV TODA).


From North Ridge Park Subdivision to Labayane Street, Commonwealth Avenue, Athertone Street and vice versa, within Barangay Sta. Monica, District II, Quezon City, with RMC of ten (10) units, the same to be serviced by North Ridge at Palmera Tricycle Operators and Drivers Association (NAPATODA)."

SECTION 2. This Ordinance shall take effect immediately upon its approval
