AN ORDINANCE APPROVING THE SUBDIVISION PLAN OF A RESIDENTIAL SUBDIVISION (BP BLG. 220) WITH 11-LOTS, COMMUNITY MORTGAGE PROGRAM, CONTAINING AN AREA OF FIVE HUNDRED EIGHTEEN (518) SQUARE METERS, COVERED BY TRANSFER CERTIFICATE OF TITLE NUMBERED RT-61936 (47932) OF THE REGISTRY OF DEEDS OF QUEZON CITY, REGISTERED IN THE NAME OF REMIGIA P. ARTES, AND LOCATED AT LOT NO. 23-C (LRC), VILLAREAL STREET, BARANGAY GULOD, NOVALICHES, QUEZON CITY, METRO MANILA, AS APPLIED FOR BY THE ARTES HOMEOWNERS ASSOCIATION, INC., REPRESENTED BY JOSEPHINE G. TEMPORADA, SUBJECT TO THE CONDITIONS PRESCRIBED UNDER QUEZON CITY ORDINANCE NO. SP-56, S-93 AND BATAS PAMBANSA. BLG 220.
