AN ORDINANCE APPROVING THE SUBDIVISION PLAN OF SIGMA TOWNHOUSES : A 3-STOREY TOWNHOUSE PROJECT (8-UNITS), CONTAINING AN AREA OF EIGHT HUNDRED (800) SQUARE METERS COVERED BY TRANSFER CERTIFICATES OF TITLE NUMBERED N-168468 & N-168465 OF THE REGISTRY OF DEEDS OF QUEZON CITY, REGISTERED IN THE NAME OF GRRD REALTY HOLDINGS CORP., AND LOCATED AT LOTS 2 & 4 BLOCK 4 (LRC) PSD-7764, SIGMA STREET, ALPHA VILLAGE, BARANGAY OLD BALARA, QUEZON CITY, METRO MANILA, AS APPLIED FOR BY GRRD REALTY HOLDINGS CORP., WITH OFFICE ADDRESS AT 1401 TOWER 1 & EXCHANGE PLAZA, AYALA AVENUE, MAKATI CITY, METRO MANILA, SUBJECT TO THE CONDITIONS PRESCRIBED UNDER QUEZON CITY ORDINANCE NO. SP-56, S-93 AND PD 957.

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED :

Section 1.
