ORDINANCE NO. SP-807, S-99

AN ORDINANCE APPROPRIATING THE SUM OF FOUR MILLION ONE HUNDRED FIFTEEN THOUSAND AND SEVEN HUNDRED NINETY PESOS (P4,115,790.00) FOR THE IMMEDIATE RIP-RAPPING OF THE PORTION OF TULLAHAN RIVER LOCATED AT AREA 5, BARANGAY GULOD, QUEZON CITY.

Introduced by Councilor ERIC Z. MEDINA.

WHEREAS, one of the primordial concerns of the government is to ensure the safety and protection of its inhabitants;

WHEREAS, Section 458 (a) (1) (iv) of R.A. 7160, otherwise known as the "Local Government Code of 1991", explicitly provides that the Sangguniang Panlungsod may:

"Adopt measures to protect the inhabitants of the city from the harmful effects of man-made or natural disasters and calamities, x x x.";

WHEREAS, the residents of Lot 735, Area 5, Florentina Street, Barangay Gulod, Quezon City, are always living in fear that one day their houses might be hit by the continuous erosion along Tullahan River caused by the abnormal current of the river, aggravated by heavy rain falls;

WHEREAS, the City Engineer's Office of Quezon City, in its 1st Indorsement dated August 31, 1998, recommended the amount of Four Million One Hundred Fifteen Thousand and Seven Hundred Ninety Pesos (P4,115,790.00) as the estimated cost for the rip-rapping of the said portion of Tullahan River, copy thereof is hereto attached;

WHEREAS, there is an urgent need to appropriate the said amount to prevent the impending danger;

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED:

SECTION 1. There is hereby appropriated from any available funds in the City Treasury the sum of Four Million One Hundred Fifteen Thousand and Seven Hundred Ninety Pesos (P4,115,790.00) or so much thereof as may be necessary, for the immediate rip-rapping of a portion of Tullahan River located at Area 5, Barangay Gulod, Quezon City.

SECTION 2. This Ordinance shall take effect upon its approval.


