AN ORDINANCE RENAMING COMMONWEALTH ELEMENTARY SCHOOL
NGC ANNEX TO MANUEL L. QUEZON ELEMENTARY SCHOOL.

WHEREAS, Section 13, paragraph b (3) of the Local Government Code of 1991 authorizes the sanggunian of highly urbanized cities, in consultation with the National Historical Institute (NHI), to change the name of public elementary, secondary and vocational or technical schools, community colleges and non-chartered colleges;

WHEREAS, renaming of the Commonwealth Elementary School, NGC Annex to Manuel L. Quezon Elementary School is a fitting tribute to the late Commonwealth President Manuel Luis Quezon who is likewise the founder of Quezon City;

WHEREAS, the officers and members of the General Parent-Teacher Association (Gen. PTA), thru its President, Mr. Marianito Reodava, has requested that the elementary school be named in honor of the late President Manuel L. Quezon for the following reasons;

1. No school in Quezon City has been named after the late President Manuel Luis Quezon, and
2. To accord due honor to a great statesman who is the Father of Quezon City.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN
SESSION ASSEMBLED:

SECTION 1. The name of Commonwealth Elementary School, NGC Annex, located at Barangay Commonwealth, Quezon City, is hereby renamed to Manuel L. Quezon Elementary School.
